Saturn Metals Limited (ASX: STN) (“**Saturn**”, “**the Company**”) is pleased to advise that it has awarded the contract to complete the Pre-Feasibility Study (PFS) for its flagship Apollo Hill Gold Project in WA to globally renowned engineering services firm, Kappes Cassiday & Associates (KCA). The Apollo Hill Project PFS is scheduled for completion during Q4 CY2025.
